#### **RESOLUTION I**

## Regional Bank of Foot-and-Mouth Disease Antigens

# The 41st Regular Meeting of COSALFA

#### Considering:

- Resolution I of COSALFA 40, which calls for the preparation of a draft project for the establishment of a regional bank of foot-and-mouth disease antigens and vaccines;
- Only Brazil, Panama, and Uruguay have deposited their contributions and the deposited financial resources are insufficient for the preparation of the project's full version;
- The information needed for establishing the bank must include information on the national emergency attention plans;
- The project only makes sense as a regional initiative under PHEFA;
- A record has been made of the COSALFA 41 participants' comments on the content of the draft project for the establishment of a regional bank of foot-and-mouth disease antigens and vaccines, particularly on the Region's need to maintain the competence and capabilities for the production of vaccine:

#### Resolves

- To urge the countries that have not yet contributed the funds required under the draft project to
  make their respective deposits as soon as possible, so that the technical group may prepare the
  final version of the project, including a cost/benefit analysis; and to urge further the ex-officio
  Secretariat to convene an Extraordinary Meeting of COSALFA to approve the project's final
  version.
- 2. To charge PANAFTOSA and the countries' Technical Experts Group with defining the biosecurity requirements to be met by the laboratories that will be the bank's suppliers; and with proposing the requisite evaluation mechanisms.
- 3. To charge PANAFTOSA and the countries' Technical Experts Group to perform a risk analysis to define the regional and exotic strains to be included in the bank for the production of antigens.
- 4. To urge the countries to prepare and/or update their national sanitary emergencies attention plans.

# **RESOLUTIÓN II**

# Renewal of high-level political commitment to eradicating foot-and-mouth disease and to support PHEFA

# The 41st Regular Meeting of COSALFA

#### Considering:

- The countries of the region have demonstrated their permanent interest in and commitment to acting for the eradication of foot-and-mouth disease on the continent, and stressed the importance of such eradication for the development of their herds, food security, and the socioeconomic benefit of their peoples;
- The Ministers of Agriculture and of Health gathered at the 1987 RIMSA decided to establish the Hemispheric Program for the Eradication of Foot-and-Mouth Disease-PHEFA and approved the 1988-2009 Action Plan for the disease's eradication;
- The Ministers and Secretaries of agriculture, livestock, and health and the representatives of cattle-raiser associations and other organizations involved in the livestock production chain gathered at the 2004 Hemispheric Conference on Eradication of Foot-and-Mouth Disease held in Houston renewed their political, technical, financial, and administrative commitment to eradicate foot-and-mouth disease in the Americas; and set up under COHEFA the Inter-American Group for the Eradication of Foot-and-Mouth Disease-GIEFA;
- For ten years GIEFA has coordinated strategic alliances on a continental level to realize the commitment to eradicate foot-and-mouth disease, mobilizing resources and carrying out political advocacy before the countries to elicit support for PHEFA;
- The 2010 Extraordinary Meeting of COHEFA approved PHEFA's 2011-2020 Action Plan, which established the strategic lineaments of national programs for the last phases of foot-and-mouth disease's eradication by 2020;
- In recent years most countries have enhanced their efforts and the continent has achieved the Action Plan's objectives; and for over two years the continent has recorded no foot-and-mouth disease foci, while some countries and states have recorded no case of the disease for more than ten years, a sign that PHEFA has entered its last phase;
- PAHO, as an intergovernmental institution, discharges through PANAFTOSA the function of a Reference Center on Foot-and-Mouth Disease and has played its role in extending technical cooperation to the countries under PHEFA, particularly in the final phase of eradication, especially in border zones:

 In the last phase of eradication major challenges present themselves, making indispensable the strengthening of technical cooperation in its reference character as well as the redirecting of strategies adjusted to this phase;

#### Resolves

- 1. To thank PAHO for its significant contribution and continuing support to the countries toward the eradication of foot-and-mouth disease in the sixty-three years of PANAFTOSA's existence.
- 2. To request GIEFA to convene a conference on the eradication of foot-and-mouth disease to establish and agree on action commitments demanded by the challenges of the last eradication phase, particularly in border zones in need of protection programs.
- 3. To request PAHO to convene a regular meeting of the Hemispheric Commitment for the Eradication of Foot-and-Mouth Disease (COHEFA) to review the achievements and the challenges related to PHEFA's objective and to ratify, at the countries' highest political level, their firm commitment to eradicate foot-and-mouth disease in South America.

# RESOLUTION III PHEFA's 2014-2015 Biennial Plan

# The 41st Regular Meeting of COSALFA

#### Considering:

- At the COSALFA 41 Regular Meeting the delegates were presented with the 2014-2015 Biennial Plan for their information, evaluation, and commentaries (Attached document);
- The countries agreed on the proposed technical cooperation actions by PANAFTOSA under PHEFA and concurred that these actions are crucial for PHEFA's implementation and the achievement of its goals;
- The member countries agreed on fully financing the actions approved under the 2014-2015 Biennial Plan;

#### Resolves

- 1. To bestow unanimous approval on the 2014-2015 Biennial Plan for PANAFTOSA's Technical Cooperation.
- 2. To have the public and private sectors represented at COSALFA to commit themselves to manage and provide the funds required under the Biennial Plan's budget to ensure the implementation of the technical cooperation actions and PHEFA's follow-up.
- 3. To charge PANAFTOSA with orienting the countries in respect of the specific mechanisms (Trust Fund, Agreements, Accords, and Technical Cooperation Terms) that will enable PAHO/WHO to receive funds from the member countries for implementing the technical cooperation actions under PHEFA.

- 2. To charge PANAFTOSA, as COSALFA's Secretariat, with adopting the requisite protocol and administrative measures to process the documents and acts pertaining to Surinam's adhesion do COSALFA.

- 2. To urge the two organizations to maintain international cooperation so as to ensure the consolidation of the results achieved and to contribute toward eradication's final phase.
